

1 Introduction

1.1 Intended use

The ELITe InGenius[®] system is a fully automated device integrating the following tasks: extraction and purification of nucleic acids, amplification and detection of the target sequence by Real-Time Polymerase Chain Reaction (RT-PCR) and result interpretation. The system is suitable with multiple sample types for qualitative and quantitative in vitro diagnostics applications.

The ELITe InGenius[®] system shall be operated by healthcare professionals and properly trained molecular biology technicians and can be used in combination with proprietary extraction and amplification reagents as well as custom amplification reagents.

1.2 System Overview

The ELITe InGenius system is a bench top instrument integrating all required hardware, reagent and software components to perform nucleic acid sample preparation and real-time PCR operations.

- extraction modules, liquid handling pipettors, RT-PCR units
- nucleic acid extraction and RT-PCR reagents
- dedicated software piloted with an integrated touch screen, interfacing bi-directionally with the Laboratory Informatics System (LIS).

The ELITe InGenius system can process from 1 to 12 samples in 12 parallel tracks. It features primary tube loading capability, a universal extraction process combined with multiple and independent PCR's from one or several extracted sample(s) enabling laboratories to develop custom test panels according to their specific needs.

The extracted nucleic acid can be stored for retesting or archiving.

Several operational modes are available: nucleic acid extraction only, RT-PCR amplification only, or nucleic acid extraction, RT-PCR amplification and result analysis.

Instrument

The ELITe InGenius is able to automatically perform the following operations:

- Nucleic acid extraction and purification based on magnetic beads technology with optional ultra-sonication capabilities.
- Amplification and detection by RT-PCR of the target sequence
- Liquid handling operations including sample & reagent dispensing
- Barcode reading with an integrated barcode reader for extraction cassette and PCR cassette, or with a hand-held barcode reader for samples and RT PCR reagents

The ELITe InGenius instrument features the following components

Single Nozzle Pipettor

- operates the SX, SZ, SP axis.
- sample transfer from the primary tube to the secondary tube, nucleic acid and RT-PCR reagents dispensing
- dispensed volume ranges from 5 to 300 μL , using 300 μL filter tips

Twelve Nozzle Axis

- operates in the Y-Z-P axis and performed various tasks:
- magnetic particle capture for extraction
- liquid handling operations during extraction and extracted nucleic acid elution
- dispensed volume ranges from 10 to 1000 µL

Both Single Nozzle and Twelve Nozzle Axis are equipped with liquid sensors to detect sample and reagent liquid levels, clots, tips and liquid leakage.

Detection Nozzle Axis

- Real Time Fluorescence Detection.
- PCR well capping and uncapping.

M - Axis

• Assists extraction using magnetic extraction.

Twelve Extraction Modules

- each equipped with a heat block
- ultra-sonication available for any combination of samples
- three elution volumes available: 50 μ L, 100 μ L, 200 μ L

Twelve RT-PCR units

- independent temperature control allows parallel diverse PCR thermal-profiles.
- Peltier block 1 peltier element for every well
- Reaction volume range from 20µL to 50µL
- Melt curve analysis capability
- Six fluorescent channels are available for each RT-PCR with the following specifications:

The ELITe InGenius is organized in 12 parallel **Tracks** enabling to process in parallel and independently 12 samples processed from extraction to amplification. The loading of the reagents and consumables is performed in dedicated ELITe InGenius racks.

Reagents and Consumables

ELITe InGenius SP 200

- 8-wells prefilled, unitary cassette sealed with aluminum foil containing all the necessary reagents for cell lysis, extraction and purification including the magnetic beads.
- Universal cassette suitable for human genomic DNA and viral DNA/RNA and validated on a very large range of sample matrices.




Figure 1.3: Nucleic acid extraction principle and ELITe InGenius SP 200 extraction cassette

- The reagent set has been optimized for the isolation of nucleic acids from 200 µL samples(Figure 1.3: ELITe InGenius – SP200 Extraction cassette and extraction principle).

Additional Extraction kits, using similar configurations, can be used on the System to expand clinical applications. Each extraction kit will use the corresponding method present in the software.

ELITe InGenius SP 1000

- 8-wells prefilled, unitary cassette sealed with aluminum foil containing all the necessary reagents for cell lysis, extraction and purification including the magnetic beads.
- Universal cassette suitable for human genomic DNA and viral DNA/RNA and validated on a very large range of sample matrices.




Figure 1.4: Nucleic acid extraction principle and ELITe InGenius SP 1000 extraction cassette

- The reagent set has been optimized for the isolation of nucleic acids from up to 1 mL of samples. (Figure 1.4: ELITe InGenius SP1000 Extraction cassette and extraction principle).

Additional Extraction kits, using similar configurations, can be used on the System to expand clinical applications. Each extraction kit will use the corresponding method present in the software.

ELITe InGenius SP RNA

- 8-wells prefilled, unitary cassette sealed with aluminum foil containing all the necessary reagents for cell lysis, extraction and purification including the magnetic beads.
- Universal cassette suitable for RNA extraction and purification from lympho-monocyte suspensions and leukocyte suspensions from clinical samples of peripheral blood.




Figure 1.5: RNA extraction principle and ELITe InGenius SP RNA extraction cassette

- The reagent set has been optimized for the isolation of nucleic acids from 0.2 mL samples. (Figure 1.5: ELITe InGenius SP RNA Extraction cassette and extraction principle).

Additional Extraction kits, using similar configurations, can be used on the System to expand clinical applications. Each extraction kit will use the corresponding method present in the software.

ELITE InGenius DNase I containing a lyophilized endonuclease, aliquoted into 48 ready-to-use test tubes. The DNase I tubes must be used with the ELITe InGenius DNase I tube adapter.

ELITe InGenius DNase tube adapter kit containing 12 DNase I tube adapter and an uncapped tool.

ELITe InGenius SP 200 Consumable Set containing all necessary consumables for extraction along with the extraction kit:

- extraction tubes
- tips cassettes, including one piercing tip for automated extraction cassette piercing and one pipetting tip for sample processing
- nucleic acid storage tube and screw caps.

The following ELITe InGenius consumables are necessary for RT-PCR amplification in open and closed mode.

ELITe InGenius PCR cassette: universal PCR vessel and caps for IVD and user defined assay protocol (Figure 1.6: ELITe InGenius - PCR cassette)

1.3 Workflow

The ELITe InGenius system operates in CLOSED or OPEN mode.

The CLOSED mode enables the user to run only IVD assay protocols. The CLOSED mode is also considered as a depository including all the IVD validated assay protocol according to the IFUs of the ELITE MGB assays in use. Modification of assay protocols or creation of a new assay protocol are not allowed in the CLOSED mode.

The OPEN mode enables the user to run also additional non-IVD user-defined assay protocols developed by the laboratory to fit their specific needs.

ELITe InGenius workflow with IVD assay protocol

- 1. Start the ELITe InGenius system
- 2. Select the CLOSED mode
- 3. Select the extraction elution volume
- 4. Query the LIS to import the sample work list
- 5. Select IVD assay protocol or testing panel for each sample
- 6. Load ELITe InGenius extraction reagents & consumables
- 7. Load ELITe InGenius amplification reagents
- 8. Load the scanned samples
- 9. Start the run
- 10. Approve result
- 11. Upload data to the LIS

ELITe InGenius workflow with EGSPA protocol & user-defined and user-validated protocol

- 1. Start the ELITe InGenius system
- 2. Select the OPEN mode
- 3. Select the extraction elution volume
- 4. If needed, query the LIS to import the sample work list*
- 5. Select user-defined assay protocol or panel for each sample and/or EGSPA assay protocol previously imported without modification from the CLOSE mode*
- 6. Load ELITe InGenius extraction reagents & consumables
- 7. Load user-defined amplification reagents (and/or ELITe MGB® RT-PCR reagents)
- 8. Load the scanned samples
- 9. Start the run
- During run, optional pause after dispensation from primary tubes to the secondary and after the PCR set up can be selected in order to unload primary tubes or eluates from the system
- 11. Approve result*

Upload data to the LIS (if needed) *see NOTE below

Assay controls is recommended once every two weeks for each parameter running one positive and one negative control.

One assay calibration per PCR reagent batch is mandatory running one positive and one negative control.

Any analytical result obtained through OPEN mode assay is under complete responsibility of users.



• The user must carefully read the instructions about appropriate use of the system.

Only items supplied by ELITechGroup or representative should be used. The use of not approved items may affect the safe operation of the system or cause damage to the system.



2.1 Handling of the Instructions for Use

The Instructions for Use is provided for your safety and provides important instructions for the handling of the system described.

- o Read all instructions.
- Keep the Instructions for Use near the system.
- o The Instructions for Use must be accessible to the user at all times.

The *ELITe InGenius* instrument is designed and manufactured in accordance with the safety requirements for electronic and medical systems. It is the operator's responsibility to comply with local and national laws, regulations, and laboratory procedures for installation and operation of the instrument.

The manufacturer has done everything possible to guarantee that the equipment functions safely, both electrically and mechanically. The instruments are tested by the manufacturer and are supplied in a condition that allows safe and reliable operation.

Non-Observance of Safety Instructions

Laboratory Equipment

2.3 Electrical Safety



Electrocution/Fire Hazard

Avoiding rules and regulations can cause serious personal injuries with deadly consequences and material damages.

 National rules and legal regulations for the safe electrical operation of the system must be observed.



Electrocution/Fire Hazard

Improper connection of the system and the peripheral devices to mains supply can cause serious personal injuries with deadly consequences and material damages (e.g. fire).

- The electromagnetic environment shall be evaluated before setup and operation of the instrument,
- Do not use the instrument in the proximity of sources with excessive electromagnetic radiation (e.g. unshielded, deliberately operated high frequency sources) as these could interfere with the proper operation of the instrument.

2.4 Laser and UV-Light Safety

Eye Injuries due to Laser Radiation



- a) Laser radiation cause eye irritation when you look directly into the laser beam. During operation of laser, inform all people around the instrument to avoid watching the laser beam.
- o Never look directly into the laser beam.
- Do not use optical devices (e.g. mirrors).
- o Take off watches and mirroring jewellery before operating the laser.

- Keep the instrument door closed during UV sterilization.

2.5 Mechanical Safety

Danger of Electrocution or Mechanical Injuries by Missing or Open Protective Covers

To avoid serious injuries with deadly consequences due to electrocution or injuries by the system (e.g. contusion, cuts etc.), protective covers may only be opened, bypassed, or removed for certain maintenance procedures and with the highest level of caution by authorized and trained personell.

- o Only perform maintenance procedures described in this manual or dedicated TSB's.
- Make sure that no one is working on the system and that all covers are attached and closed before reconnecting the system to the mains supply.
- o Make sure that all covers are attached before switching on the instrument.
- Switch off the system, separate it from the mains supply and protect the system against restarting, if protective coversor gear is missing.
- Make sure that the motion of the pipettor has stopped before opening covers and/or accessing the working area of the instrument.
- o Avoid touching the pipettor and other moving parts while the system is in operation.
- o Perform all maintenance procedures with the highest level of caution.
- o Do not wear clothes or accessories which can be caught by the system.
- System malfunction or unexpected movement can cause injury. Keep away, shut down and remove power supply in such cases.

2.6 Heat Hazards



Improper placement during installation of the system may cause fire or serious system damage due to overheating.

- Select the place of installation of the system so that the ventilation airducts are not blocked or covered.
- Select the place of installation of the system so that air can circulate freely.
- Do not touch the hot collar or PCR block during or immediately after PCR process. To minimize the risk for the users the system automatically decreases the temperature after PCR completion.
- $\circ\,$ Pay attention to heated areas accessible to user during removal/placement of consumables.

2.7 Biological Hazard



Risk of infection

Biological samples used in association with the *ELITe InGenius* system have the potential to transmit infectious diseases. Follow all applicable national and international laboratory safety regulations.

There are biological hazards during the following user activities:

- Sample handling
- Eluate handling
- Waste disposal (fluids and consumables)
- Maintenance and cleaning

The following guidance must be observed:

- a) Observe local and national provisions, legislation and laboratory regulations.
- b) Use appropriate gloves
- c) Use an appropriate lab coat!
- d) Use appropriate eye protection (e.g. goggles)
- e) Avoid contact between skin/mucous membrane and samples/test reagents or parts of the instrument.
- f) Clean, disinfect and decontaminate the system immediately if potentially infectious material has been spilled.
- g) In case of spills of reagent or samples, wash and clean by using 70% alcohol and dispose treating cleaning material as potentially infectious.
- h) Do not use broken or chipped tubes or bottles.
- i) Observe the instructions in the package inserts for correct use of reagents.



- j) Observe the legal regulations for the handling of infectious material.
- k) Never use bio-hazardous liquids for testing the instrument!
- I) Do not drink or eat eat in laboratories.

2.8 Chemical Hazards or Safety

There is possibility of exposure to hazardous chemicals through handling of reagents, calibrators or controls. Observe the following to minimize the risk of accidental spilling of chemical agents (in the sample loading sample area, cooling block area, consumable areas ...) when handling of reagents, calibrators or controls

- a) Carefully read and follow the SDS for each assay.
- b) Wear recommended protection such as disposable gloves / lab coat / eye protection to prevent exposure.
- c) In case of exposure, follow the guidance on the SDS.
- d) Follow all applicable national and international laboratory safety regulations.

2.9 Electromagnetic Interference

ELITe InGenius is designed and manufactured in compliance with applicable EMC standards. For current information about applicable standards, please refer to the CE Declaration of Conformity for this instrument.

The user must ensure that a compatible electromagnetic environment for this instrument is maintained in order to ensure the device will perform as intended.

- Only use instrument and cables supplied by ELITechGroup S.p.A. to maintain compliance.
- Installation should be done only by trained service staff approved by ELITechGroup S.p.A. or representative.
- Do not use the instrument near a source of electromagnetic radiation, such as an instrument without appropriate shield, or an instrument or equipment without appropriate EMC certification.

2.10 Residual Risks for User Safety

This section explains potential residual risks to the user after certain safety measures have been taken. The user should carefully read and understand these residual risks and follow guidance in order to use the ELITe InGenius system in a safe manner.

2.10.1 Design and Manufacturing Process for Safety

The ELITe InGenius system was designed and manufactured with a risk management system to eliminate or reduce risks to the user as much as possible. Using this

instrument in a manner not specified by ELITechGroup S.p.A. may compromise the safety protection designed into the equipment.

The user must carefully read the instructions about appropriate use of the system. Only items supplied by ELITechGroup S.p.A. or representative should be used. The use of non-approved items may affect the safe operation of the system or cause damage to the system.

2.10.2 Ergonomics

Ergonomic principles were considered in the design of the ELITe InGenius system to reduce discomfort, fatigue, and physical stress to the user.

2.10.3 Power Supply Interruption

If power is interrupted during use of the ELITe InGenius, the system will not automatically restart. The system will need to be manually restarted by the user.

2.10.4 Protection Against Mechanical Hazards

Care was taken in the design of the ELITe InGenius to protect the user from sharp edges and rough surfaces. There are also safety systems in place to stop the operation of the instrument if the door is opened. It is strictly prohibited to remove the door, covers, or alter the built-in safety mechanisms in any manner.

2.10.5 Protection Against Biological Hazards

Always observe local and national provisions, legislation, and laboratory regulations and standard practices to minimize biological hazard.

- a) Do not operate the ELITe InGenius system or handle consumables or potentially contaminated items without wearing appropriate personal protective equipment (PPE). Consult the appropriate SDS for requirements.
- b) Do not handle sample specimens without wearing appropriate personal protective equipment.

2.10.6 Protection Against CyberSecurity Hazards

To safeguard the ELITe InGenius system against CyberSecurity hazards the following instructions shall be noted.

WARNING



It is recommended to use immunized USB memory sticks to avoid and prevent the automatic start up, through the Windows auto-run mechanism, of any malware applications prior to use with the ELITe InGenius System.

WARNING



If it is necessary to connect the ELITe InGenius system to a network (Ethernet), this connection **could be** directly protected against cyber-attacks using a hardware firewall device (possibly equipped with antivirus). The hardware firewall should block all network addresses that are not necessary for the operation of the ELITe InGenius system. Please contact your local ELITechGroup technical service support partner for further firewall hardware and configuration recommendations.

NOTE

Only ELITechGroup approved software updates shall be installed to the ELITe InGenius system. These shall only be installed by ELITechGroup trained and approved personnel.

NOTE

The use of the ELITe InGenius system, if connected to the laboratory / hospital computer network, can be monitored to identify any anomalies or suspicious behavior by the network administrator.

Any anomalies that could compromise the correct functioning of the instrument shall be reported to ELITechGroup support staff immediately and the system should not be used until checked by ELITechGroup.

NOTE

An external keyboard and mouse shall not be connected to the ELITe InGenius system unless specifically indicated by your ELITechGroup technical service support partner.

NOTE

The ELITe InGenius system can be connected remotely to allow technical assistance activities. The remote assistance service to be used is the one validated and issued by ELITechGroup and which allows to guarantee effective, safe and integrated support, significantly reducing the time to solve problems without the need to install any software on the remote stations and in compliance with the current GDPR regulation (EU Reg. 2016/679 and subsequent transposition into national legislation Legislative Decree 101/2018).

The solution used by ELITechGroup is a Cloud solution that uses data centers that have obtained the ISO / IEC 27001 certification of their information security management systems. In addition, all data centers completed the following exams: SOC II Type 1, SSAE 16, SOC 1 Type II and SOC 2 Type II.

2.10.7 **Protection Against Electrical Hazards**

The ELITe InGenius system was designed and produced to prevent electrical shock or electrostatic hazards. A fuse is installed for overcurrent protection. Strictly follow local and national regulations for safety.

The ELITe InGenius system was designed for indoor laboratory use only. Do not operate the instrument in an explosive environment or atmosphere. End user is responsible for safe use:

- a) Do not interrupt the electrical ground contact
- b) Do not connect other electric devices to the same plug or electrical outlet (unless authorized by ELITechGroup S.p.A. or trained representative).
- c) Do not use damaged wiring.
- d) If safe use is impossible, disconnect the system from mains power supply. Do not use damaged instrument.
- e) Do not open the locked cover during operation.
- f) Do not attempt internal repairs. Refer servicing to qualified service personnel.

2.10.8 **Protection Against High Temperature Hazards**

A hot collar is installed in the system to prevent condensation during PCR. There is a Caution Hot Surface label near the hot collar. Handle with care.

2.10.9 Protection Against Noise Hazards

The instrument is designed and produced to keep the A-weighted emission sound to be less than 70dB at distances at least 1 meter away.

3 Safety labels / Instrument labelling

3.1 Instrument Type Plate

The serial number is unique for each instrument.

3.2 Power Switch

The main power switch is located on the right side of the instrument.

In case of emergency, the user can shutdown the instrument by switching this switch to the OFF position.

3.3 Hot Surface Label

A Caution Hot Surface label is located near the hot collar and heating block. Handle with care.



3.4 Mechanical Hazard Label

The ELITe InGenius system has many moving parts inside. The door is equipped with a locking mechanism to prevent opening during use. The system is also designed to shut down if the door is opened during use. However, a Caution Mechanical Hazard label is located inside the instrument. Handle with care.





3.5 Biohazard Label

A Biohazard warning label is attached inside the instrument. There is a potential biohazard risk if the user does not adhere to good laboratory practices and follow all local and national regulations for safety. Operator must wear all recommended PPE.





4 **Operational precautions and limitations**

In order to safely obtain reliable results from the instrument, users must strictly adhere to this manual. Using the instrument in a manner not specified by ELITechGroup S.p.A. is prohibited and may impair the safety protection designed into the equipment, lead to injury, and affect results.

4.1 General requirement

- a) Keep away from heat generating sources.
- b) Keep out of direct sunlight.
- c) Operate the instrument only within the defined operating temperature range.

d) Maintain the defined minimum space on all sides of the instrument at all times. This is important for:

- i) Maintaining reliable temperature control
- ii) Preventing overheating of the system and/or serious system damage
- iii) Maintaining functionality of electrical and detection systems
- iv) Preserving instrument life
- v) Providing sufficient access for maintenance

Minimum useful lifecycle of the ELITe InGenius system is five (5) years, providing the system is maintained by qualified personell.

4.2 Installation of the system

The ELITe InGenius system installation may only be performed by ELITechGroup S.p.A. or trained representative service staff. The ELITe InGenius system must be connected to ground.

4.3 Removal of the system

If the instrument will be move from where installed now, be sure to contact the manufacturer.

If the instrument will be relocated to another installation site or must be returned for repair or service, only an ELITechGroup S.p.A. or trained representative is authorized to do so.

5 System Operation

The ELITe InGenius instrument is supplied with a built in user interface that runs the ELITe InGenius software.

CAUTION	Use of Approved Software
	Use only approved ELITe InGenius instrument software to operate the instrument and to generate assay results.

The following chapters describes the basic process of starting up the instrument, setting up and executing a run, approving the run results and shutting down the instrument.

Most of the basic functions of the ELITe InGenius software are described in chapters 5.

Some additional basic functions and more advanced functions are described in chapter 6.

Maintenance functions are described in chapter 0.

5.1 Starting the Instrument



To avoid injury due to moving parts, the instrument initialization cannot be performed when the door is open. During startup, the system requires the user to confirm the door is closed.

- 1. Close Door
- 2. Turn on the power switch which is located on the right side of the instrument.
- 3. The instrument starts the ELITe InGenius software on the integrated PC. The system displays the start-up screen while the start-up checks are being performed.




Figure 5-1: Software Initialization.



If an error is detected during the system start-up checks, the running of assays will be locked out until the problem is resolved.

Refer to Chapter 7 "Error Handling and Troubleshooting" to resolve the problem.



The following table summarizes the main functions that can be accessed from the Home Screen:

Perform Run

Used for setting up and accessing the details for a run while it is in progress.

Depending on the progress of the run, selecting the Perform Run icon will display one of three different screens as follows:

RUN progress	Destination screen
Run not started	Setup Run Screen
Run in progress	Run Status Screen
Run completed	Run Result Screen

End of Day

Used for Shutting down the system at the end of the day. If a run is in progress, this button is disabled until the run has completed.

Results Search

Used to access the database of completed Run Results.

Calibration

Displays Calibration Manager screen.

Controls

Displays Controls Manager screen.

At the bottom of the screen there are additional buttons for for configuring and managing the instrument.

Logout

Logs the current user out.

System Settings

Displays the System Settings Screen (Administrator and Service Users only).

Maintenance

Displays the Maintenance software (Service User only).

Home

Shortcut back to the Home Screen.

Up

Navigate to previously viewed screen.

Help

Displays instructions for accessing this user manual on the ElitechGroup website: http://www.elitechgroup.com/corporate/ifu-emd.

5.3 Runs, Assays, Controls and Calibrators

The term "RUN" is used to refer to a group of between one and twelve assays that are processed during a single sample-to-answer cycle on the twelve tracks of the instrument. Between 1 and 12 tracks may be included in a run with any configuration of tracks.



Figure 5-4: A Twelve Assay Run

Assay Programs are the settings used to instruct the ELITe InGenius system on how to analyse each sample on the tracks of the instrument. Each assay may be one of three types

- Patient Sample Assays
- Calibration Assays
- Control Assays

Patient Sample Assays may be run as Extraction Only, Extraction + PCR or PCR only.

An assay will yield either a Quantitative or Qualitative result according to the setup by the Assay developer. An optional Melt analysis may also be specified to be run after completing the PCR amplification. It is also possible for an Assay developer to configure assays that carry out no result interpretation and to report only C_t and T_m results.

Typically, to give a diagnostic result for a Quantitative Patient Sample Assay, the ELITe InGenius Software will need to have an approved Calibration Curve and one or more approved Control results stored in its database. For a Qualitative Patient Sample Assay, only the approved Control results will be needed.

A Calibration (Standard) Curve is generated by the software by running a special type of Assay called a "Calibration Assay". Typically, the Calibration Assay will be setup to run a series of reactions with a set of Calibrator fluids (e.g. 10⁵ copies, 10⁴ copies, 10³ copies, 10² copies). The software will then automatically calculate the Standard curve parameters that may then be used to determine the DNA titer for Patient Sample Assays.

A Control result is generated by the software by running a "Control Assay". Control Assays are typically used for running Positive and Negative controls that are then used to validate the results generated by Patient Sample Assays.

The results of running Calibration Assays and Control Assays are stored within the ELITe InGenius database and may remain valid for several weeks, removing the need to run a new Calibrator or Control with every Patient Sample.

For efficiency, it is possible to create Calibration curves and Control results *in the same run* as Patient samples, or in a separate run. If you do choose to run Calibration or Control Assays in the same run as your patient samples, you will need gain approval first for the Calibration Assay Results, then the Control Results and finally the patient Sample Results. This is known as sequential approval and is necessary to ensure that the Patient Sample Results are calculated on the most recent Calibration curves.

To setup a Run- on your ELITe InGenius system, it should have been configured with at least the following configuration information:

- Assay Programs (Patient Sample, Control, Calibrator as required)
- Calibrator Details (for quantitative assays)
- Control Details

If the required configuration is not available on your system, refer to sections 6.5 and 6.6, for further details on how to setup your system.




Figure 5-5: Relationship between Calibrator, Control and Patient Sample Assays

NOTE

It is possible to run Calibrator, Control and Patient Sample Assays in the same run (e.g. to combine Run A, Run B and Run C in Figure 5-5) and use Sequential Approval to approve the results.

5.4 Performing a Run

To perform a Run, the following sequence of activities should be followed:

- 1. Check Calibration and Control Status
- 2. Configure the Run
- 3. Setup Inventory Manager
- 4. Load Consumables and Samples
- 5. Monitor Run Progress
- 6. Review Results and Approve
- 7. Unload at end of run

5.4.1 Step 1: Check Calibration and Control Status

5.4.1.1 Check Status of Calibration

If you wish to run an Assay that gives a Quantitative result (this might be either a Patient Sample Assay, or a Quantitative Control Assay) then before setting up the run it is advised to check that an Approved Calibration (Standard) Curve is available in the database.

NOTE If you only wish to run Qualitative assays, the Calibration Status check can be skipped

Display the "Calibration" screen by pressing the "Calibration" button on the Home Screen.

This screen may be used to:

- View the details and status of each calibration curve stored on the system
 - lot number of the Mono-mix used to generate each calibration curve
 - traceability information for the Calibration fluids used to generate each calibration curve
 - expiry date for the calibration curve
 - status (Need to run, Approval Pending, Approved, Expired)
 - View the actual Calibration Curves stored on the system
- View the process settings and number of levels for the Calibrators
- Register New Calibrators
- Remove Calibration Curves from the database

When running a Quantitative Assay, it is necessary to use the same Lot number of Monoreagent as was used to create the Calibration Curve. If you wish to use multiple lots of Mono-reagent, then it is necessary to create a Calibration Curve for each lot number.

These settings are usually provided by the Assay Developer and are registered in the database when loading the Assay settings onto the system.

It is also possible to add new Calibrator settings independently from the loading of Assays by pressing the "Add New" button in the Calibration Manager Screen and then using the "Barcode Scan" or "Flash Drive" buttons in this screen.

NOTE	It is possible to define a different number of replicates for each calibrator level as well as to specify the tube color that will be shown in the run setup screen. This is intended to help guide the user and thus reduce the risk of loading calibrator fluids to the wrong tracks.
NOTE	The software will not allow calibrator settings to be deleted or modified if there are test

results in the database that depend on this data.

If a Calibration Curve has been created for a Calibrator, the "View Chart" button will be activated in the Calibration Manager screen. By clicking on this button, it is possible to view the Calibration Results and Calibration Curve as in the example below:

This screen will show the most recent Calibration Curve for each Calibrator / Mono-mix.

It is possible for an Administrator or Service user to Approve Calibration Curves in this screen.

In case of calibration levels replicates, it is possible to exclude outliers and recalculate values when needed.

It is also possible to generate a printed or .pdf format report by clicking the "PRINT" button from this screen.

The Detailed Info tab of this screen shows further information about the Run that was used to generate the Calibration Curve, including the results from each reaction as well as the lot numbers and expiry dates for each reagent and calibrator fluid that was used in the run.




Figure 5-16: Run Setup Screen.

5.4.2.1 Configuring Assays to be Run

Select the "Extraction Input Volume" and "Extracted Eluate Volume" by touching on the corresponding fields above the main grid. The ELITe InGenius Software uses these settings to filter the list of Assays to ensure that all tracks have the same Input and Output volume settings.

NOTE Put the Sample Tubes on the rack in the same order indicated in grid table. The position in the Sample Carrier of the Sample Tubes is very important for the traceability of results. Place the sample tubes without caps.

NOTE It is possible to perform Quantitative and Qualitative Assays in the same Run as long as all the Assays you wish to run have the same Extraction Input Volume and Extracted Eluate Volume requirements.

Each row in the grid corresponds to a single track on the instrument working area.

For each track in turn:

- Enter the Sample ID (SID) for Patient Samples.
 - If the sample tube does not have a barcode, it is necessary to enter the Sample ID (SID) manually. Click on the SampleID cell for the track to be setup and enter the SID manually using the on-screen keyboard.
 - If the sample tube has a bar code, click on the SampleID cell and then use the Handheld Barcode to load the SID into the system.
- Choose the Assay to be run in the track by clicking in the "Assay" cell for the track to be setup and selecting the required Assay from the list that is presented.

The list of Assays can be filtered by adding text in the box at the top of the Assay Selection List. The list can also be re-ordered by touching on the column headings (Name, Type, Matrix).

If you cannot find an Assay in the list that you would expect to see, check the Extraction Input Volume and Extracted Eluate Volume settings in case these are causing the Assay to be filtered out from the list.

	If the source track is performing PCR only, it is not possible for the SW to check the volume of Eluate placed in the source track, so cannot check that sufficient Eluate is available for all the tracks sharing the Eluate.
	 If you have logged in to "OPEN" mode, it is possible to modify the Dilution factor setting for tracks that are running Patient Samples. 


Figure 5-28: "Template Already Exists" Warning.




Figure 5-31: Mono-reagent Lot Number advisory message

A Calibration Assay will typically require several different concentration reference fluids to be run. The results from this run will be used by the ELITe InGenius Software to calculate a Calibration (Standard) Curve that may be used by other Assays to convert from C_t results to actual DNA concentration values (copies/mL, gEq/mL, IU/mL or user defined units).

In the Run Setup Screen, a Calibration Assay is selected in the same way as any other Assay from the Assay Selection List. In this example the Calibrator Assay can be identified using the "Type" column on the Assay Selection screen where "Calibrators" is shown next to the Assay Name.

5.4.2.8 Example Run Settings for a Control Assay

A Control Assay will require at least one reference fluid to be run. In the case of a Control with several levels, more than one fluid will need to be run.

The results from a Control run will be used by the ELITe InGenius Software to generate one or more Control Plot that may be Approved as showing statistically valid results. The Control Approval will then be used by other Assays to determine if a valid result may be reported.

It is normal to run at least a Positive and a Negative control for an Assay, each with their own assay program.

In the Run Setup Screen, a Control Assay is selected in the same way as any other Assay from the Assay Selection List. In this example two Control Assays can be identified using the "Type" column on the Assay Selection screen where "Controls" is shown next to the Assay Name.

5.4.3 Step 3: Load Reagents, Consumables & Samples

The next step in preparing the ELITe InGenius to run assays is to setup the Inventory Manager.

The Inventory Manager is a cooled block used to hold PCR Mono-reagent and Internal Control fluids, as well as an area for storing the Single Tips used that are used for moving the fluids to the 12 tracks.

The ELITe InGenius Software supports up to ten different block configurations that can be recalled at will. This feature allows the definition of a number of different configurations to support the most commonly used Assay Panels.

The ELITe InGenius Software maintains traceability and usage information for each reagent loaded in each block:

- Reagent name
- Reagent expiry date
- Reagent lot number
- Number of tests remaining in tube




Figure 5-41: Waste container placement on the Instrument.




Figure 5-49: Inventory Manager Save Confirmation.




Figure 5-51: Inventory Manager Save Confirmation.




Figure 5-54: Expired Reagents in Inventory Manager




Figure 5-57: Inventory Manager Single Tips placement on the Instrument.




Figure 5-58: Tip Rack Screen.




Figure 5-59: Confirmation of Tip Rack Replacement




Figure 5-60: PCR cassette loading guidance.




Figure 5-62: Extraction cassette loading guidance.




Figure 5-65: Scan window




Figure 5-70: Tip loading guidance.




Figure 5-72: Sonication Rack.




Figure 5-75: Extraction Tube loading guidance




Figure 5-81: "During Run" display.




Figure 5-82: Abort run confirmation.




Figure 5-85: Results Display Graph.




Figure 5-90: Uploading Results to LIS




Figure 5-94: Targets highlighted in green.




Figure 5-98: Ct = 0 for samples manually approved.




Figure 5-101: Results options.




Figure 5-111: Calibration Screen – Detailed information

For a Qualitative Control the Y axis shows the C_t for the track. A red marker line shows the Approval Pass/Fail C_t threshold as programmed by the Assay developer.

For Positive Qualitative Controls, the software checks that the calculated Ct is be below the Pass/Fail threshold to allow the result to be Approved, while for a Negative Qualitative Control, the software checks that the calculated Ct is above the Pass/Fail threshold before allowing result Approval.

For assays that utilize Melting Controls, a further plot for Tm's is also generated in addition to the Ct plots. This can be viewed by selecting the Tm radio button on the right side of the screen. In some cases, more than one Tm point is expected for a give channel; the pass/fail range is indicated on the graph by the pale blue horizontal areas (if the point is within the blue bar, it's a pass; if it's outside the bar, it's a fail)

On the right hand side of the Control Screen, further details are given about the Controls in the text box.

Above the Control Plot, the tabs are used to select between the different levels and different targets (if these are used) within the Control Set.

By clicking on the "Detail Info" tab in the Control Screen, detailed info about the control run can be displayed. The Detail Info tab has further sub-tabs that can be clicked to show similar information to the Run Results screen, but specific to the selected control tracks.

5.4.5.9 Approving Controls Results

If the all of the levels and targets contained within the Control Set yield acceptable results (i.e. All tracks amplify satisfactorily and the C_t / SD validations pass), the "Approval" button will be enabled in the Control Screen.

Click the "Approval" button on the Control Screen to approve the Control Plots so that they will be available for validating results in other related Assays.

If the person approving the results has only an Operator account, the ELITe InGenius System will request that the credentials for an Analyst, Administrator or Service User to allow the Approval to be given. If the person approving the results has the necessary role, this step will be skipped.




Figure 5-122: Exporting Run Data




Figure 5-124: Example of Files Generated by Data Export




Figure 5-125: End of Run Button




Figure 5-12688: Reminder for unapproved results




Figure 5-127: End Of Run Screen

In this screen, you can narrow the search by filling out the fields to specify parameters that will be used to filter the results returned from the database.

Fields that are left blank will be matched to any value in the database (i.e. behave as a wildcard).

Press the "Search" button to perform the search.

The "Last 10 Runs" button provides a shortcut to access the most recent runs in the database.

Once the database search has completed, matching Runs are listed in the Search Results screen.

Each row in the Search Results represents a single Run. Each row includes a summary of the assays that were run in each of the tracks within the Run.

This screen may be used to Approve previously unapproved results or to re-attempt the upload of results to the LIS if this had failed previously.

5.6 Shutting Down the Instrument at End of Day

At the end of each day you should perform the following steps to shut down the system. The ELITe InGenius software will guide you through this procedure when you select the "End of Day" option from the Home Screen. If a Run is currently in progress, you will need to wait until the Run completes before you will be able to select the "End of Day" option.




Figure 5-130: End of Day screen.

Open the front door.

Remove the block from the Inventory Area and store it in the refrigerator.

5.6.1 UV Sterilisation

The instrument working area may be sterilised using the built-in UV lamp. You must select the sterilisation function manually by clicking on the "UV Irradiation" button prior to shutting down the instrument. The UV sterilisation process is an optional step of the shut down process.




Figure 5-90: Selecting shutdown options for after UV sterilisation completes.

6 Advanced Functions

The following functions are only accessible from an Administrator or Service user account. It is not possible to access these functions using an Operator or Analyst user account.

6.1 System Settings

Before using the system, it is advisable to configure some initial settings and user accounts. A default Administrator account is provided to provide access to the System Settings on first use of the system.

The "System Settings" menu is accessed by selecting the "System Settings" icon at the bottom of the Home screen. This icon will be greyed out and disabled if you are logged in as an Operator or Analyst.




Figure 6-1: System Settings screen.

6.2 Lab Details

This screen allows you to configure the contact details and logo for your institution or laboratory. These details are included on all printed reports that are generated by the system.

This screen also allows you to define the "Instrument Name" that is shown on the user interface and printed reports.




Figure 6-8: Date and Time Settings




Figure 6-13: Plot Color Settings

6.4.7 Logger

Separate log files are created for each day. The "Date" picker allows the switching between historical logs.

In details, from the "Logger" screen, select "Export Log". Then, in the "Select the log to be exported" window choose the option for "Logs in a predefined range" and choose the appropriate date range in the "From" and "To" boxes.

Afterwards, press the OK button and in the folder menu select the USB flash drive you inserted as the location to save the data.

Press again the OK button and then you will see a "Log Successfully exported" message when the download is complete.

After pressing the last OK, remove the USB flash drive from the instrument. In this way, Log files will be in a compressed (zip) format and will have a date code as the file name as follows: ExportLog_yyyymmdd_hhmmss.zip. There is no need to extract the file before sending to ELITechGroup Technical Support for review.

ELITE InGenius 6.5.1 Loading from Flash Drive An external USB memory stick needs to be connected to the InGenius system via the NOTE USB connector to use this function. WARNING It is recommended to scan USB memory sticks for viruses using third-party anti-virus software prior to attaching them to the InGenius System. 1. Insert a USB memory stick containing the Assay Program files into the USB port of the InGenius System. 2. Press "Flash Drive" button. Navigate to the Assay Program file on the USB memory stick using the on-screen 3. dialogue. 4. Press "OK" button to load the selected Assay Program file. 5. Once the information has been read from the USB memory stick, the Assay Information is displayed on the screen. As well as loading the Assay program itself, the system will also attempt to load any NOTE additional configuration data it needs to run the assay such as settings for Calibrators, Controls, Reagents, Sample Matrix etc. These additional settings will only be loaded if they are not already registered in the ELITe InGenius system.

6.6 Creating, Editing, Copying and Deleting Assay Programs

The "Edit Assay" screen is used to:

- to create new Assay Programs.
- to edit existing "Open" Assay Programs
- to remove unused Assay Programs from the system
- to copy/rename existing "IVD Cleared" or "Open" assay programs on the system

This section describes the basic operations required to manage the Assay Programs stored on the system. Detailed information about the individual Assay Parameters and Results Interpretation Models can be found in section 6.7.

This screen can be accessed by pressing the "Edit Assay" button in the System Settings screen.

NOTE

IVD Cleared Assay Parameters are read-only on the ELITe InGenius system; no changes are possible without first copying the IVD assay.

If you make a copy of an IVD Cleared Assay Program, the original Assay Program will remain read-only; however the copied data will change to become an Open Assay Program and Assay Parameters changes are allowed.

6.6.1 Create a new Assay Program

To create a brand new Assay Program, simply start filling out the fields on the screen to configure the assay parameters.

Once you have completed the Assay Program, press the SAVE button.

The system will check that all the necessary parameters have been specified then ask you to provide a name for the Assay Program.

6.6.2 Edit an existing Assay Program

To edit an existing Assay Program, press the Edit button and then select the assay that you wish to edit from the list that is presented.

When you select one of the Assay Programs from the list, its parameters will be loaded to the Edit Assay screen and if the Assay Program is an Open Assay, you will then be able to save your changes to the Assay Program using the Save Button. If the Assay Program is IVD Cleared, you will only be able to view the parameters.

When saving a changed Assay Program, you will be asked to confirm the name for the Assay Program before the Save operation is completed. It is possible to change the name used for the Assay Program at this stage.

6.6.3 Delete an existing Assay Program

To delete an existing Assay Program, press the Edit button and then select the assay that you wish to delete from the list that is presented (see Figure 6-)

When you select one of the Assay Programs from the list, its parameters will be loaded to the Edit Assay screen

You will then be able to delete the Assay Program by pressing the Delete Button.

6.6.4 Copy an existing Assay Program

To make a copy of an existing Assay Program, press the Copy button and then select the assay that you wish to copy from the list that is presented (see Figure 6-).

When you select one of the Assay Programs from the list, its parameters will be loaded to the Edit Assay screen and you may edit the Assay Parameters as required.

Assay Programs created using the Copy function will always be marked as Open Assays, regardless of whether the original was IVD Cleared.

After making any changes, you will then be able to save the Assay Program using the **Save** Button.

When saving a changed Assay Program, you will be asked to enter the name for the Assay Program before the Save operation is completed.

6.7 Assay Parameters and Interpretation Models

The Edit Assay screen contains several tabs that contain the settings that are used by the ELITe InGenius system to control the execution of a run and the results interpretation once the run has completed.

The ELITe InGenius system supports both IVD Cleared (Read Only) assays and Open (Editable, RUO) assays. IVD Cleared assays may be viewed in the "Edit Assay" screens but it is not possible to change any of the settings.

Assay Name

This is the name that is used in the Run Setup screen to select the assay. It should uniquely identify the assay. The name can only be edited when saving the complete Assay settings by pressing the SAVE button. The Assay Name cannot be modified by editing the entry directly on the screen

• Pathogen/Target

This field is a short text string that is used to group a number of assays together. For example, several assay programs may be created for a common target, each with a different Sample Matrix (e.g. "WB", "Plasma", "Urine")

• Sample Type

This field is used to define if the Assay program is used to update the stored calibrations or controls on the system or to generate a result for a patient sample. Different results interpretation behavior is defined in the interpretation models based on the Sample Type being processed. Separate Assay programs are required to generate control results, calibration curves and patient sample results for each pathogen (e.g. CMV CAL Assay, CMV POS CTL Assay, CMV NEG CTL Assay, CMV WB Assay)

• Sample Matrix

This field is used to choose which Sample matrix is used for the Assay. The Sample Matrix values available here are taken from the Sample Matrix Database (see section 6.8)

- Extraction Cassette Name This field is used to choose which Extraction Cassette will be used for the assay
- Extraction Input Vol.
 This field is read only and shows the input volume expected by the Extraction Cassette specified in the previous field
- Extraction Elution Vol.
 This field specifies the Eluate volume that you wish to generate from the extraction process. A pop up menu allows the selection of eluate volumes that may be generated.
- Sonication Off Time / On Time / Cycle These three fields allow the sonication parameters to be specified for the Assay. If no Sonication is needed, then set the Sonication On Time to Zero.
- Dilution Factor This specifies the primary sample dilution factor that is to be used for the assay. It is used when calculating results for quantitative assays.

• Ct's and Tm's Only

This setting can be set for Assays that only need to generate Ct's and Tm's only, and do not need to perform any further results interpretation. If Ct's and Tm's is selected, then only the Channel Configuration table needs to be completed (all other fields on this tab are disabled)

Model

This specifies which result interpretation model should be used for generating results for this assay. See below for further information on the different interpretation models that are available.

- Version/Description These fields provide further information about the selected interpretation model.
- Result Reporting Units / Conversion Factor IU

If the selected interpretation model provides a quantitative result, this field can be used to specify if results should be reported in copies/mL, gEq/mL or IU/mL. If the reporting units are set to IU/mL, you must also specify the factor for converting from copies/mL to IU/mL

Target(s)

This field specifies how many targets are to be detected within a multiplexed Assay. Since the ELITe InGenius system provides detection of up to six wavelengths, it is capable of supporting assays with up to five multiplexed targets plus an Internal control. Not all interpretation models support more than one target; contact an Elitech Product Support representative for more details.

IC(s)

This setting is determined by the selected interpretation model. Usually only one internal control is used for each assay.




Figure 6-22: Model 1 Overview




Figure 6-23: Model 2 Overview




Figure 6-24: Model 3 Overview




Figure 6-25: Model 4 Overview




Figure 6-26: Model 7 Overview




Figure 6-27: Model 11 Overview




Figure 6-31: Sample Matrix Database screen




Figure 6-33: Templates Database screen.




Figure 6-37: Reset Database Confirmation

6.13 Disable tracks




Figure 6-39: Disable Track screen

6.14 System Monitor

7 Error Handling and Troubleshooting

In case of errors during the process, different responses can be provided by the instrument. When possible the instrument automatically handles the error. In other cases, in order to avoid aborting the session, operator intervention is required.

When operator intervention is required, in order to recover manually the session from errors, the ELITe InGenius shows an Error window with error description, instrument component involved and some recovery option buttons with different actions.

7.1 List of Main Error Codes

The errors generated during the extraction and PCR Setup sessions will be traced in the report files. The error codes (ID) useful for traceability and technical service.

Barcode Reading Error

When an Error occurred during the Barcode Reading process, an executed RUN is aborted and moved to the Barcode Read Error screen.

ID Error of PCR or Extraction Cassette

This error occurred when PCR Cassette ID of Assay information, which registered in the Program Assay, is mismatch with a read ID by inner barcode reading. In this case, an Error is solved by setting an intended cassette in accordance with the Assay information on a stage.

(Procedure of Retry the Barcode Reading process)

An instrument unlocks the door automatically.

The user opens the front door.

Remove the cassette which is highlighted on the screen.

Set the registered cassette that has been registered on Program Assay screen for a PCR cassette, or on Extraction Registration screen for an Extraction cassette.

Close the front door.

Press "Retry" button.




Figure 7-2: Popup message about to confirm that the front door is closed

When a cassette that used previous RUN is used for a relevant RUN, this function makes a barcode scan as an error. If the same RUN information, that assigned as sequential number in a barcode information, detected from previous 10 RUN, this error occurs.

(Procedure of Retry in case of a used cassette is detected)

Retry the same procedure as previous section.



Used Cassette need to be discarded on a designated area.



Gloves need to be worn while operation.

Clock Block


As this unit is temperature controlled, condensation may form on the surface of the Cool Block (EXT) and the worksurface itself. The following procedure describes how to clean the block and remove the condensation.

This procedure can be also performed before starting a run.


Proceed by:

1) Extracting the Cool Block (EXT).






2) Using a Cloth or a papper towel dry the Cool Block all around, aswell as the worksurface as shown below.



3) After cleaning and drying the Cool Block (EXT) and the worksurface reinstate the Cool Block as shown below.



Weekly Maintenance

Every week wipe all interior and exterior surfaces of the instrument using a lint free cloth dampened in less than 6% hypochloryde or 70% Ethanol 30% Purified water solution. Rinse well with water to remove any residuals.

9.2 Using the ELITech Remote Access feature

In order to use the remote access software, the User should follow the follow steps

- Connect one end of a network cable to the LAN port on the instrument and the other end to a properly configured network port, identified by the customer's facility networking group.
- 2) If not already done, exit the ELITe InGenius software to the Windows Desktop.
- 3) Insert a flash drive containing a software for remote access and control (ex. VNC, TeamViewer etc.).
- 4) connect a USB keyboard with the windows key press the Windows key (see picture below) to bring up the start menu and press the "Computer" entry and then choose your flash drive.
- 5) Install the chosen software with the dedicated procedure.
- 6) From a separate computer that has a registered copy of the same software, ensure that the remote connection is functional.
