Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. We project that carbon emissions will decrease over the next five years to 262,01 tCO₂e by 2028. This is a reduction of 19,81%.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

An evident increase of emissions has been registered compared to the previous year. Highest emissions of ELITech UK are related to upstream and downstream transports, business travel and commuting. As logistics is provided by a supplier, the company has a very limited influence in terms of transportation management (i.e. vehicle selection), but can anyway act on its planning, improving this as much as possible. In 2023, incoming and outgoing goods transportation increased significantly. This explains an increase in Scope 3 emissions.

At the same time, ELITech can incentivize its employees to be more careful while scheduling business trips, and go on them only if strictly necessary, and provide one day remote work as mandatory to all the workforce, in order to have a smaller number of employees commuting every working day.

Compared to the baseline year (2022), Scope 1 and Scope 2 emissions have also increased due to structural and organisational changes which have hindered the implementation of the suggested reduction measures over the course of the last year.

Despite this overall increase, ELITech remains firmly committed to reducing its emissions in view of the Net Zero target for 2050.

Below are briefly listed the actions to be implemented in the next 5 years:

- 20% reduction of upstream and downstream product shipments through their optimization (i.e. shipment merging);
- 15% reduction of business travel, promoting online meetings;
- 20% reduction of employees commuting, through the provision of a remote work day;
- 100% purchasing of clean energy from renewable sources, replacing current non-renewable energy supplies;
- composting instead of landfill disposal of waste.

According to the above measures, CO₂e emissions are expected to be reduced by about 20% by 2028. Specifically, green energy purchasing will lead to 100% reduction of Scope 1 and Scope 2 emissions. The action planned against Scope 3 emissions, once implemented, will reduce around 80% compared to the current year.


